**Proposed change to Wabash Valley Walk to Emmaus Community By-Laws**

Article III – MEMBERSHIP

Section 2. Now reads...

- (a) “Persons who have completed a Walk to Emmaus, Chrysalis, Cursillo, Tres Dias, The Great Banquet or Journey of Faith weekend may become members by participating in activities of this Community and requesting the secretary to include their names on the mailing list.”

The same ARTICLE III – MEMBERSHIP

Section 2. Will read ...

- (a) “Persons who have completed a Walk to Emmaus, Chrysalis, Cursillo, or Tres Dias weekend may become members by participating in activities of this Community and requesting the secretary to include their names on the mailing list.”

The reason for the change is in order to comply with the International Walk to Emmaus policy. After discussion, the Board will vote by secret ballot (a two-thirds (2/3) majority of those voting is needed for passage.) After the Board has approved the change, the Community shall vote by paper ballots circulated at the next regular Gathering after the Amendment is printed in the Newsletter. Adoption will be considered valid only after the Board is satisfied that all, who will, have voted at the said Gathering and the two-thirds (2/3) majority sustained.
