### Chrysalis Fee Increases & Updated Forms:

Chrysalis has been able to maintain a reduced cost structure for many years, largely due to outside donations which have offset the rising costs. Recent cost increases for holding Flights and reduced numbers on our flights have prompted the Chrysalis Board to be in further discussion and prayer.

Please continue to pray with us for continued guidance.

We have decided to raise our fees beginning with Flight #30, which is scheduled for 4-6 September 2010, Labor Day Weekend. The new fees for both the caterpillar and team members will be increased to \$100. However, in order to promote early sponsorship and participation, the fees for early bird applications received at least 30 days before the weekend will be reduced to \$85.

A deposit of \$25 is to be submitted with the application and will be applied to the fee for the weekend.

As in the past, we shall try to make scholarships available, so if an applicant is in need of a full or partial scholarship please contact a board member to request one.
